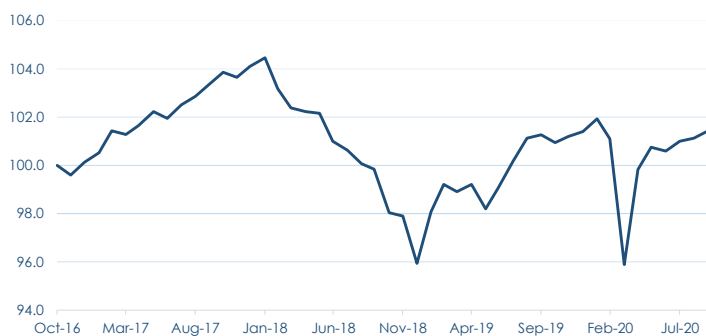

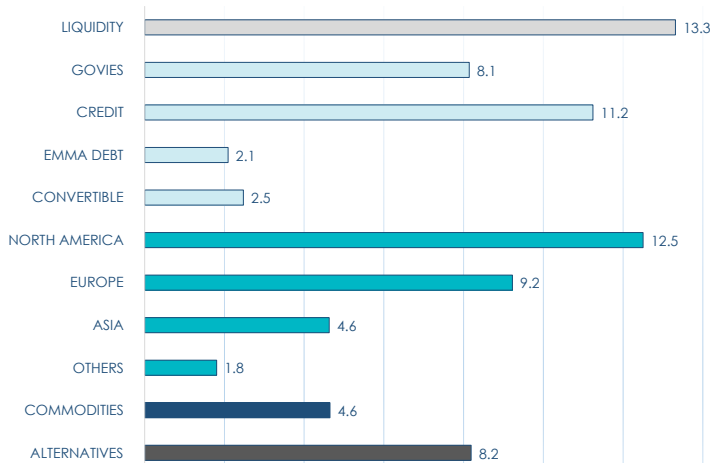
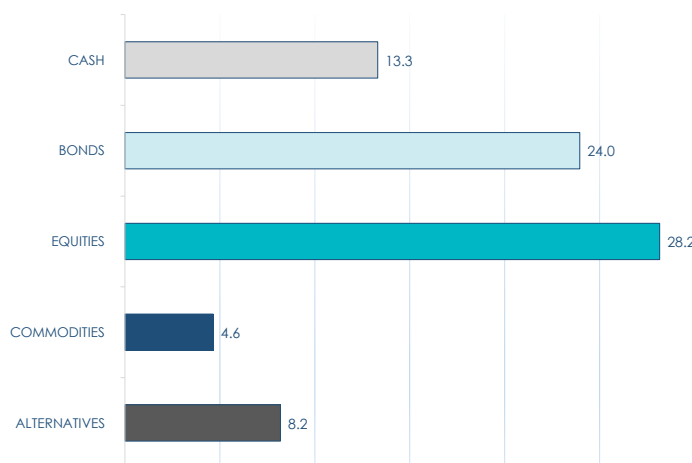
## INVESTMENT OBJECTIVE

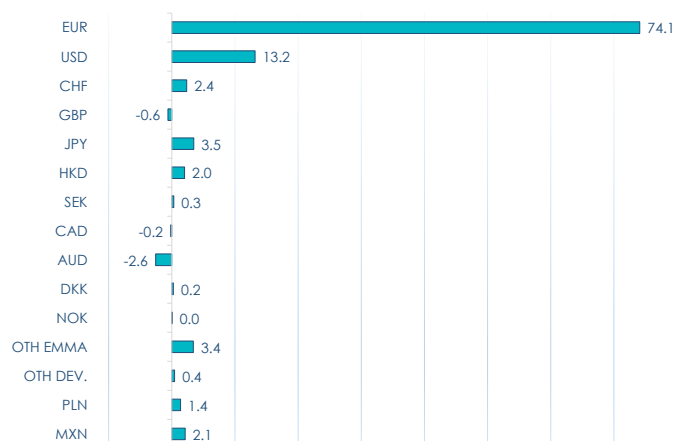

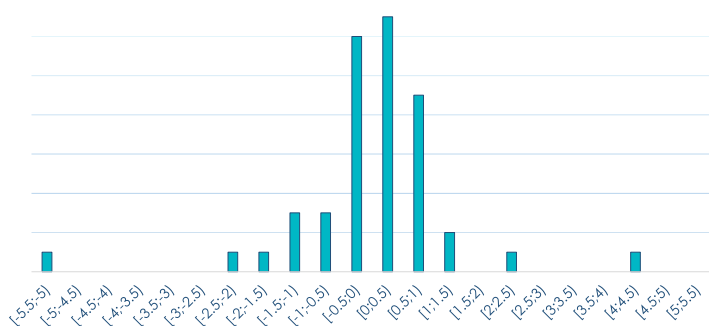
## NET CURRENCY EXPOSURE



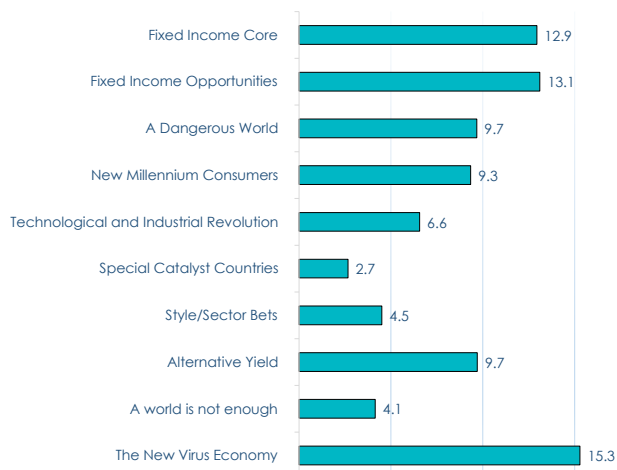

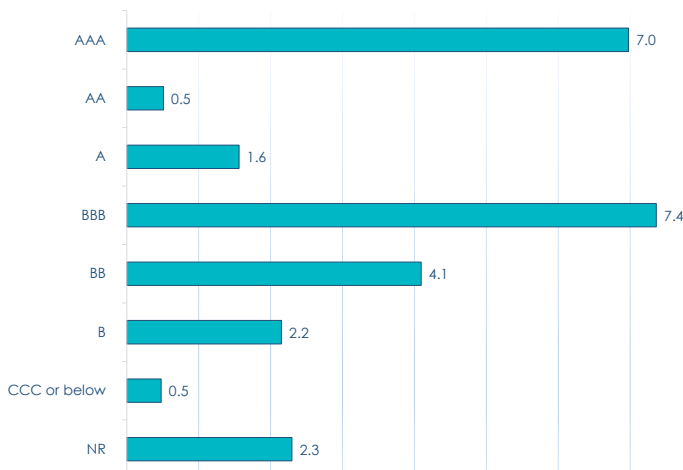
## MONTHLY RETURN DISTRIBUTION IN %



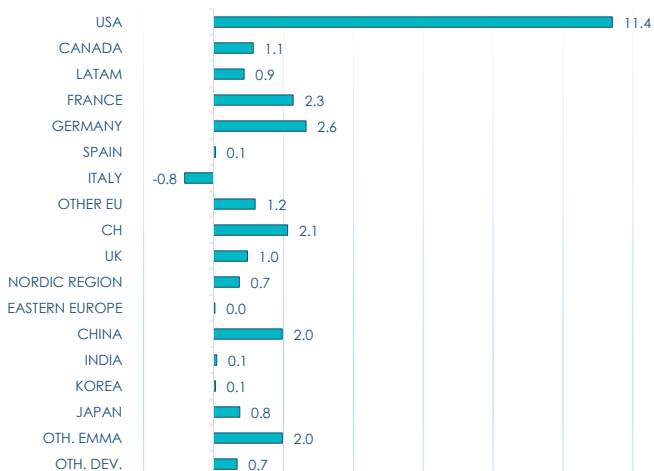

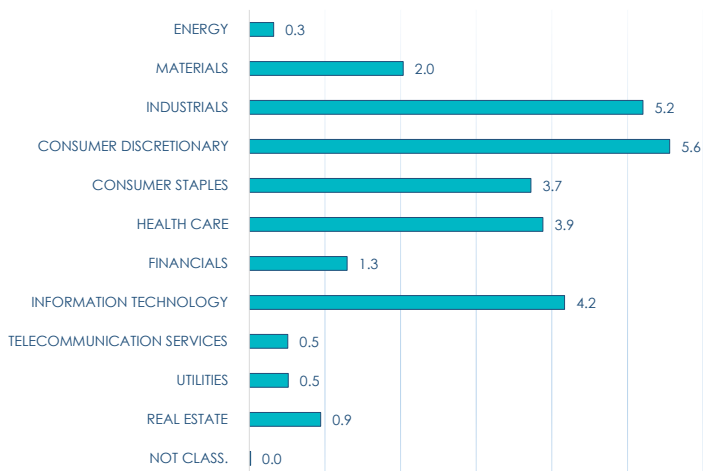
