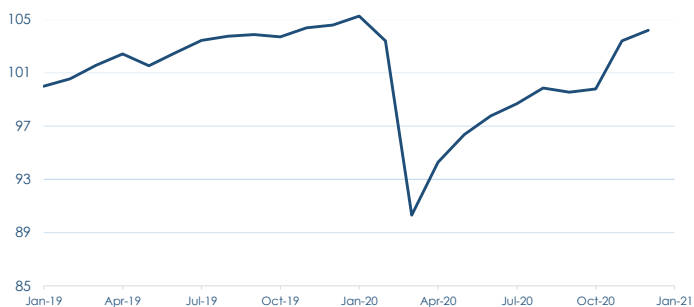

PERFORMANCE GRAPH



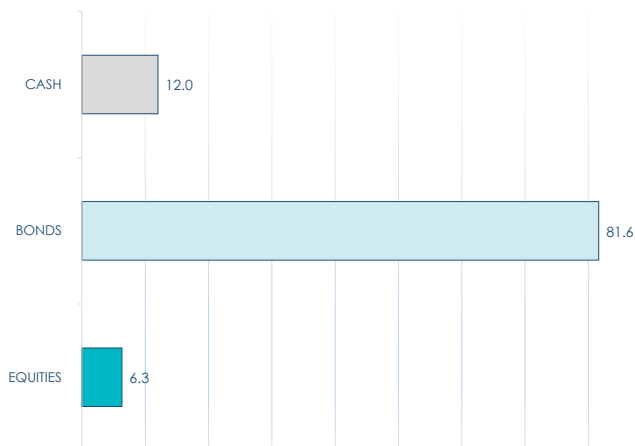
INVESTMENT OBJECTIVE

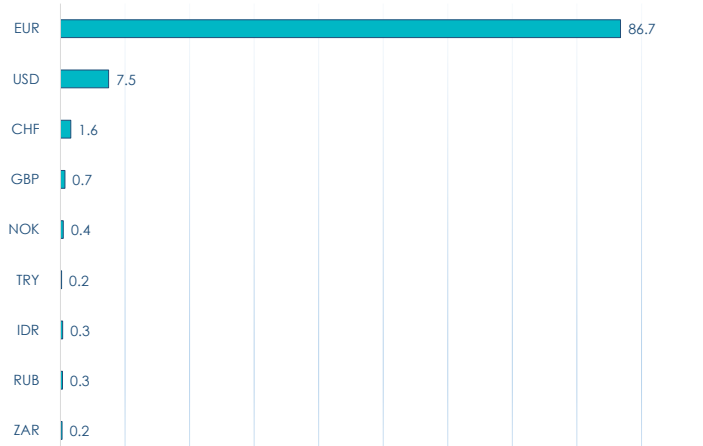

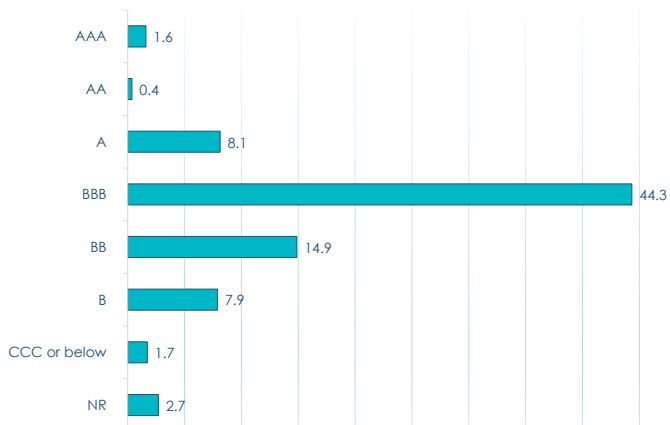
NET ASSET ALLOCATION



NET CURRENCY EXPOSURE



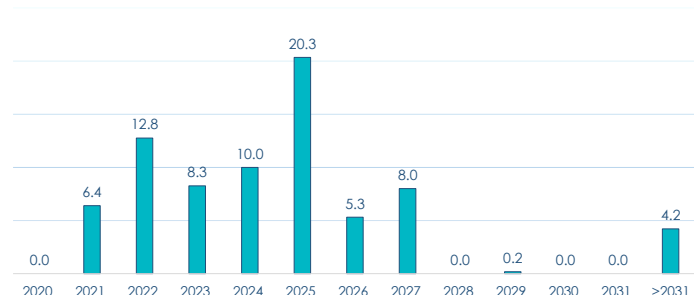

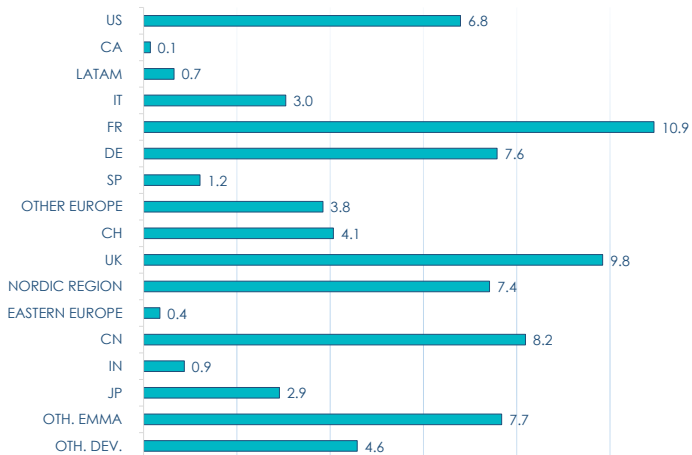

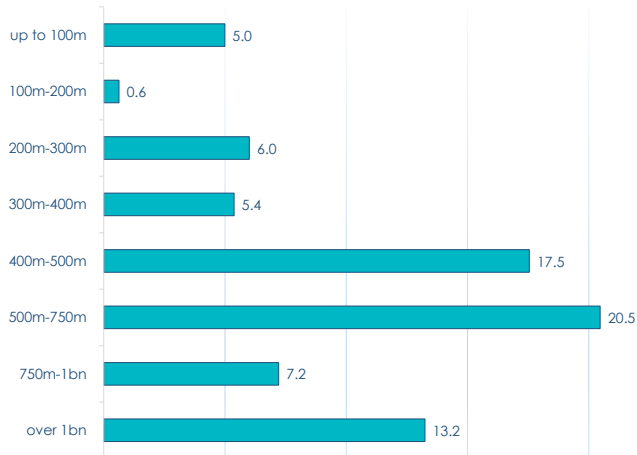
MATURITY DISTRIBUTION IN %



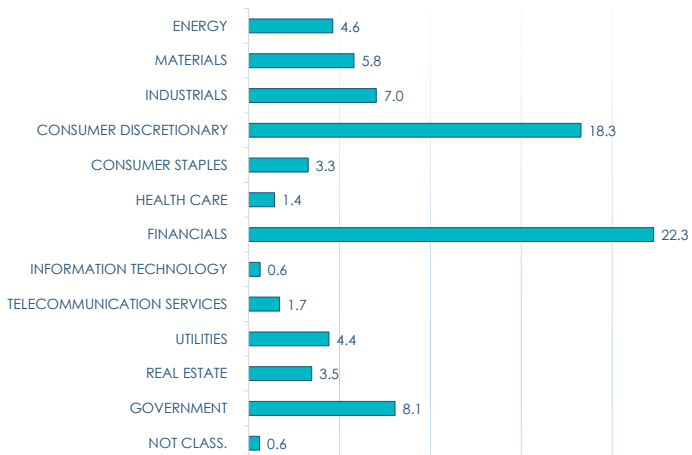
COUNTRY OF RISK EXPOSURES



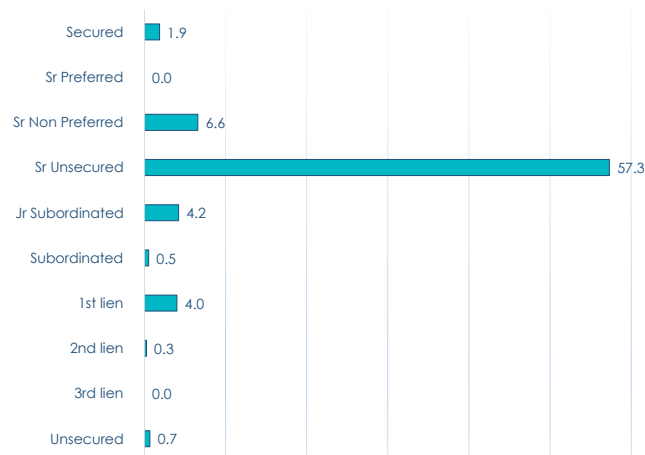
OUTSTANDING BREAKDOWN
